



# NIGERIA ENERGY TRANSITION: THE ROLE OF GAS IN ACHIEVING A LOW-CARBON ECONOMY

#### ABSTRACT

Challenges and obstacles are also addressed, including: Infrastructure gaps, Regulatory hurdles, Security concerns, Competition from renewable energy sources etc. The article concludes that gas will play a vital role in Nigeria's energy transition, enabling the country to: meet growing energy demand, reduce carbon emissions, drive economic development by leveraging its gas resources; this way, Nigeria can create a more sustainable energy future, aligning with global efforts to mitigate climate change.

As Nigeria seeks to transition towards a low-carbon economy, natural gas emerges as a pivotal component of its energy strategy. The country's abundant gas reserves position it uniquely to leverage this resource, particularly in light of global commitments to reduce carbon emissions and mitigate climate change. The Nigeria Liquefied Natural Gas (NLNG) and the Ajaokuta-Kaduna-Kano (AKK) gas pipeline projects serve as a compelling case study, illustrating how gas can facilitate this transition while promoting economic growth. Natural gas is often viewed as a cleaner alternative to coal and oil, producing lower carbon emissions when combusted. In Nigeria, where energy demand is rising due to population growth and industrialization, the potential of gas to support a more sustainable energy landscape is significant. The country holds the ninth-largest gas reserves globally, and topmost in Africa estimated at over 200 trillion cubic feet (Fig. 1: International Energy Agency, 2022, International Gas Union, 2022).

Nigeria's energy sector is dominated by fossil fuels, contributing to climate change and environmental degradation. ## Case 1: The NLNG Project: A Model for Sustainable Energy

The NLNG project, established in 1989, is a joint venture between the Nigerian government and several international oil companies. Its primary objective is to process Nigeria's natural gas for export, thus generating revenue and reducing flaring—a practice that contributes significantly to greenhouse gas emissions. The project has played a crucial role in positioning Nigeria as a significant player in the global LNG market, with exports reaching over 22 million metric tonnes per year as of 2023 (Nigeria LNG Limited, 2023).

As the world moves towards more stringent climate goals, Nigeria's strategy of leveraging natural gas through projects like NLNG is crucial. It allows the country to meet immediate energy demands while aligning with global low-carbon aspirations. By fostering a conducive environment for investment in gas infrastructure and renewable energy, Nigeria can pave the way for a sustainable energy future. The NLNG project exemplifies how gas can be utilized to support economic and environmental goals. By converting natural gas into LNG, the project not only mitigates emissions but also creates jobs, stimulates local economies, and enhances Nigeria's energy security. Moreover, the revenue generated from LNG exports can be reinvested into renewable energy projects, further diversifying Nigeria's energy portfolio.

## Case 2: The AKK Project: Enhancing Gas Infrastructure

The Ajaokuta-Kaduna-Kano (AKK) gas pipeline project which began in 2020 and expected to be completed in 2025 is another significant case study, illustrating how natural gas can support economic growth, low carbon economy, energy security and environmental sustainability. The AKK project is a landmark initiative designed to enhance Nigeria's gas infrastructure. Spanning approximately 614 kilometers, the pipeline aims to transport natural gas from the southern (Ajaokuta) gas-producing regions to the northern (Kaduna-Zaria-Kano) parts of the country





(Nigerian National Petroleum Corporation [NNPC], 2020). By improving access to gas, the AKK project is expected to stimulate industrial growth, enhance power generation and reduce the reliance on more carbon-intensive fuels.

The project is expected to deliver around 2.2 billion cubic feet of gas per day, providing a significant boost to Nigeria's energy supply. By integrating natural gas into the national grid, the AKK pipeline can help increase electricity generation, which is essential for industrialization and economic development (Oluwaseun, 2021). This enhanced energy access is vital for achieving Nigeria's long-term economic goals. Utilizing natural gas through initiatives like the AKK project can lead to substantial environmental benefits. This is because natural gas is cleaner-burning than oil and coal, making it a suitable transitional fuel that can significantly reduce carbon emissions from the various users in the sector (Figure 4). However, challenges remain in fully realizing the potential of gas. These include the need for robust regulatory frameworks, infrastructure development and investment to ensure the reliable supply of gas (Federal Ministry of Petroleum Resources, 2021).

## **Security Concerns**

Security issues complicate Nigeria's energy transition. The country faces significant challenges related to insurgency, vandalism and theft, particularly in the oil and gas sectors. These threats not only endanger infrastructure but also deter foreign investment, which is critical for funding renewable energy initiatives. For instance, attacks on pipelines and energy facilities have led to substantial revenue losses and increased operational costs for energy companies (International Crisis Group, 2022). Enhancing security measures and fostering partnerships between the government, private sector and local communities are vital steps in mitigating these risks

## **Regulatory Hurdles**

Regulatory challenges impede progress in Nigeria's energy transition. The lack of a coherent policy framework and inconsistent regulations create uncertainty for investors and project developers. While the Nigerian government has made strides through policies like the Renewable Energy Master Plan (REMP), the implementation remains uneven (Federal Ministry of Power, 2020). The energy transition in Nigeria necessitates a balanced approach that incorporates both fossil fuels and renewable energy sources. While natural gas will play a vital role in the interim, the ultimate goal should be to develop a diverse and sustainable energy mix. The Nigerian government has set targets for renewable energy deployment, including solar and wind, which can complement gas in reducing carbon emissions. Streamlining regulations and ensuring a stable policy environment are crucial for attracting investment and facilitating the development of renewable energy projects. Clear guidelines regarding incentives, grid access and tariffs are necessary to build investor confidence. (Federal Ministry of Petroleum Resources, 2021).

One significant issue is the misalignment between domestic pricing structures and global market trends. While international markets demand competitive prices, the Nigerian government regulates domestic prices, often setting them lower than global benchmarks. This discrepancy discourages investments in gas infrastructure and exploration, as investors prioritize markets offering higher returns (Aigbedion & Iyayi, 2020). The uncertainty surrounding gas pricing policies creates market instability, affecting long-term contracts and investment decisions (Ogbeifun & Ezenwafor, 2021). Additionally, gas producers contend with operational inefficiencies, poor pipeline networks, gas flaring etc, which further escalate production costs, ultimately influencing pricing strategies (Adewuyi & Ademola, 2019). Again, the issue of subsidy management in Nigeria's energy sector complicates pricing, as subsidized rates hinder cost-reflective pricing models. These challenges necessitate reforms aimed at balancing government control with market-driven pricing mechanisms, fostering investment and promoting sustainable energy development.

### **Competition Within the Energy Sector**

The competitive landscape of Nigeria's energy sector presents another layer of complexity. Traditional energy sources, particularly oil and gas, dominate the market, making it challenging for renewable energy to gain a foothold. The entrenched interests of fossil fuel industries often lead to resistance against policies promoting the transition to renewables (Olaoye et al., 2021). The competition for investment and resources can result in a fragmented approach to energy development, where initiatives may not align with national goals (probably because of the investment in the oil sector due to the huge reserves as seen in Fig. 6). Creating a balanced energy policy that supports both traditional and renewable energy sources is essential for a successful transition.
